As of May 23, 2015, there were 15 warning letters issued describing violations of Code of Federal Regulations Title 21 - Food and Drugs Part 58 Good Laboratory Practice for Nonclinical Laboratory Studies. Within these warning letters, 96 violations are listed in this book. The analysis also includes summary of FDA Inspectional Observation issued on Form 483.
